Lent is Approaching

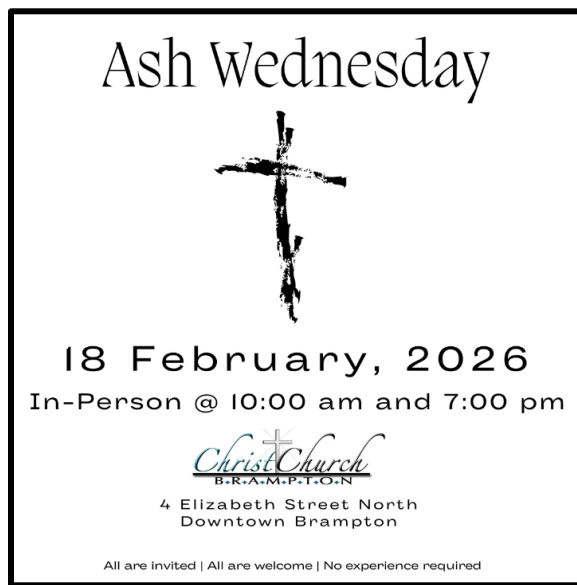

Resource Management | 2nd Quarter Results

Below are the financial results for the first two quarters of fiscal 2026 (from July 1, 2025, to December 31, 2025). This is very good news.

We have been spending more than we have been taking in for the last two years. At the end of the first quarter (ending September 1, 2025; results released on November 2, 2025) we had a big deficit and had spent most of our savings. We had faith that God was doing good things at Christ Church and there would be a solution to our problem. After prayer and planning, we launched the Generation-to-Generation Campaign.

The congregation has responded generously, and many have pledged to increase their giving. The church leadership is humbled by God's blessing to Christ Church and by the generosity of the parishioners.

We were able to make up for the deficit by the end of December. We will, however, continue to closely monitor spending in the months ahead. Thank you to those who helped to ensure that our financial situation in December is better when we last reported to you with September results. We are so grateful.

Note 1: The appointment of both a full-time Incumbent and Curate in F2026 vs. a part-time Interim Priest-in-Charge in F2025 resulted in an increase in salaries which we planned for and is partially off-set by a Diocesan Grant.

Our Generation-to-Generation campaign formally concluded on the Reign of Christ (November 23, 2025) and we are now pleased to provide the results:

✝	The bottom line is that our campaign was incredibly successful. Thanks be to God. With 57 pledges submitted, a group of people increased their total donations by \$43,000!
✝	While we hoped to have more people respond to making a pledge to our parish family (currently our response rate is 25%), we are encouraged that some parishioners responded with one-time gifts that are not included in the \$43,000.
✝	Several pledges included an increase in Pre-Authorized Givings resulting in our monthly PAR increasing by \$1,000/month.
✝	We provide several ways to have pledges fulfilled including Envelopes, PAR, CanadaHelps and E-transfers. Please do take advantage of one of these methods. <i>See below for further details.</i>
✝	Thank you to our Envelope Secretary, Ruth Wiggins, for gathering the pledge information and providing it to us in an aggregate manner.
