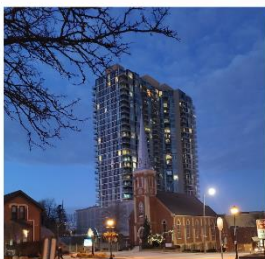

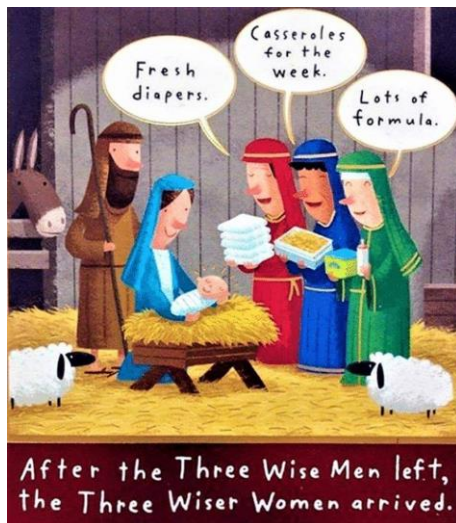
Financial Giving

2023 Envelopes Are Available

- ✘ They are listed in alphabetical order and located in the Narthex.
- ✘ **As at January 1st, 2023, all parishioners are asked to destroy any and all previous years' envelopes ~ this ensures accurate tax receipting.**

Over the years, some numbers have been reassigned as a result of parishioners taking advantage of Pre-Authorized Remittance ("PAR") thereby reducing the number of boxed sets.

Additionally, a review is taken each year as to update our envelope subscriber listing to ensure we have current information. If you have any doubt as to your current Envelope Number, please contact me directly.

- ✘ **Many Envelope Subscribers have moved to e-transfer** and we continue to be grateful for your offerings. We have provided sets for these households this year. For 2023, those making e-transfers will maintain the same envelope number. Over the year, we will be exploring how best to reduce some of these sets.
- ✘ Should your envelope set not be available, you desire an envelope set or wish to switch/start Pre-Authorized Remittance, again please feel free to contact me or leave a note at the church office.
